Councillor resigns

Being a councillor in the Town of Aurora just "wasn't what I expected," Grace Marsh told The Auroran shortly after she announced her resignation from the council she was elected to less than two years ago. She was under the belief that councillors would respect each other, and that meetings would end when they were supposed to.

"That hasn't happened," she said.

However, her resignation did have something to do with an unruly council meeting that occurred last Tuesday night, but she also felt past meetings did not live up to her expectations.

"When I ran for council it was never my intention or expectation that I would not fulfill my commitment and I certainly did not expect the role of councillor to be easy," she said. "I did, however, fully expect a schedule that would be manageable and meeting lengths that were reasonable, only occasionally excessive."

To various degrees, Mrs. Marsh said her expectations were not the realities of the current council.

"Whether it is a case of my expectations not being reasonable, or whether there truly is a unique atmosphere this term, either way, I personally felt it was a situation that I could no longer tolerate."

In a letter to The Auroran, the councillor offered her "humble apologies to the taxpayers of Aurora and my sincere thanks to those who have supported me and continue to do so".

Her letter appears in this week's Auroran on Page 7.

Mrs. Marsh is only the second person to resign the post while in office since October, 1973, when Councillor Don Roberts, citing extra pressures in his educational career, called it quits.

In December, 1972, Mayor Dick Illingworth was forced to resign

when his full time position with the Province of Ontario became a conflict of interest with his position as Aurora mayor.

Another vacancy on council was created when in January, 1965, Aurora Reeve Jean Moffat died.

According to town clerk Bob Panizza, Aurora Council now has three options.

Councillors can vote to appoint a person to council, take the next finisher from the last election or call a by-election.

The person finishing in ninth for the eight available seats was John Gallo, who was not available for comment.

If council elects to call a by-election, which, according to Mr. Panizza, would not be as extensive as a full election, it would have to cover the entire community since Aurora does not have a ward system.

Cost of such an exercise would range between \$30,000 and \$40,000, he said.

Council was expected to make a decision at a special meeting Monday night, but results were too late for The Auroran's press time.

Klees hopes to stop fraud

Newmarket-Aurora MPP Frank Klees wants residents to be aware that if they get an offer at the door for home renovations that sounds too good to be true, it probably is.

Klees held a news conference in his Aurora constituency office Friday to alert residents to what he called a "potential consumer scam".

He took the action after receiving a call from Aurora residents Dieter and Toni Scholz who told him they had an offer from a door to door salesman that didn't sound quite right.

They were quoted \$6,700 to have their windows replaced and were told that they would get a grant from the Ontario government of \$5,000 if they agreed to a home energy audit.

And to kick it all off, they just had to give the salesman a cheque for \$1,000 and he would look after the rest.

"Fortunately the couple didn't cut a cheque," said Klees. "What we don't know, is how many unsuspecting people did and I want to alert residents to the fact that this activity is taking place in their neighbourhood".

Klees has asked the fraud unit of York Regional Police to investigate and has asked the Ministry of Energy to post an alert on the website that pro-

motes the province's Home Energy Audit and Home Energy Retrofit program.

"The audit and retrofit programs are legitimate government programs and can save homeowners money on their renovation costs," he said. "The problem is that some illegitimate players may be using those programs to rip off innocent consumers."

Klees pointed out that energy audits are provided by authorized energy advisors and the costs are in the range of \$300 of which 50 per cent will be

reimbursed by the Ontario government. The Scholz's were asked to pay \$1,000.

"Clearly, something doesn't add up here," said Klees. "Not only is the upfront fee out of line, the quote for renovation work to be done was unrealistically low. It all points to a scam in the making and we want to stop it in its tracks."

Immigrants flocked to Canada locations after ad campaign

*Amendments to the Immigration Act,
Fond memories, they bring back,
I was an Ontario People Hunter,
And we didn't get much flack.*

- Poor Richard's Scrapbook

Immigration legislation is a hot topic these days with the federal government proposing changes to the Immigration Act and including the proposals in the budget bill.

Then I saw a news item about the Toronto Police Service looking for recruits and that triggered a lot of memories.

I became a "People Hunter" in 1965 when I joined the Ontario Government Public Service with the Ontario Immigration Service of the Ministry of Trade and Development.

It was not generally well known at that time that immigration was a joint responsibility between the federal government and the provinces under the former British North America Act.

Provinces could solicit, entice, encourage or recruit any person as long as they met the immigration criteria of the federal government.

Any Ontario business or organization unable to find the professional or skilled help they needed locally came to us and we tried to find them overseas and bring them to Ontario.

In the late 1960s, I noted a news item that a recruiting team of the Toronto Police Service had been travelling across the country to recruit suitable applicants without success.

One day I was having lunch at the Military Institute in Toronto when I ran into Police Chief John MacKay and over lunch I asked him if he had ever considered recruiting overseas.

It was a new idea to him but he was interested.

I explained our service and suggested he place a small ad in a London, England, newspaper at a cost of about \$500 and see what happened.

He agreed and the ad was placed through the Ministry's office in Ontario House in London.

The response was almost immediate and spectacular as hundreds of applications were received.

In fact there were so many they called to turn off the tap.

This resulted in a recruiting team of three including Inspector Charles Bond, a doctor and a personnel officer flying to London where an office was waiting for them in Ontario House with Ministry staff contacting the applicants and arranging interviews.

They were there six weeks and if I remember correctly interviewed about 600 applicants.

Evidently, the Toronto Police Service had a rule that they wouldn't poach officers from another force, but if they wanted to come on their own, there was a job open for them.

This offer was made to the British police officers and many of them accepted.

Ontario House staff worked with the federal immigration officers to process the immigration procedures and they flew to Toronto with their families to start their new duties with the Toronto Police Service.

In 1967, the Toronto branch handled personnel requests from 447 Ontario companies and organizations spending a total of \$96,000 on advertising in Britain.

In 1968, the largest single category signed up overseas was that of school teachers as 75 school boards throughout the province recruited overseas, bringing an estimated 600 teachers to Ontario.

In addition, some immigrants who came to Ontario on their own, visited the Toronto office and were assisted in providing job information and arranging interviews.

We also recruited in the United States and recruiting missions were held in various cities including Los Angeles, Cleveland and Philadelphia.

When unemployment began to climb in Ontario in the early 1970s, it became politically unpopular to bring in skilled workers from overseas, while many Ontarians were out of work, and the People Hunter service ended.

I assumed other duties in the Ministry resulting in an assignment in Sudbury to help organize the Region of Sudbury, but that's another story.

An Open Letter to the Minister of Education

Dear Minister,

I will dispense with the accustomed pleasantries as I have already congratulated you on your election win in my last letter to you - the 33rd such missive I believe in this one-way exchange of documents.

Your Conservative predecessor was right; there is a "crisis" in the schools.

These kids are lucky enough to have Palm Pilots! Where exactly are my taxes going, I might ask?

The article then goes on to note that Ridgewood has taken a stand.

"In 2002, Ridgewood pioneered an annual event called Ready, Set, Relax! The idea is that one day a year this alpha town takes a breather: teachers assign no homework, extracurricular activities are cancelled, and parents make a point of coming home early from the office...the aim is to cast off the tyranny of the timetable."

Hogwash, I say.

Minister, in the name of increased globalization and international competitiveness concerns, don't allow a similar activity here.

Forget thinking about an Ontario Ready, Set, Relax! Day.

And like a wildebeest, it has returned in greater numbers.


So the purchaser sheepishly moves all of these items into the garage, or the basement, or some other dark corner.

Volunteering should cause change in tax system: reader

The following letter was sent to Honourable Stephen Harper, Prime Minister of Canada; Honourable James Flaherty, Minister of Finance of Canada;

Receiver General of Canada, with a copy sent to The Auroran.

Dear Sirs:

I would like to suggest the following for

your perusal to make a substantial change in our Canadian taxation system:

"That individual Canadian taxpayers be allowed to deduct volunteer hours from

their Income Tax on the same basis that monetary contributions to registered charities are authorized."

The same rule of submitting receipts would apply with the registered charities preparing and legitimizing their authenticity. These receipts would be treated exactly the same as monetary donations.

There are several sound reasons for this change:

- Volunteer time should be considered to have a monetary value - a \$ value can be placed on manpower if paid position.

- Registered charities depend on volunteers. A greater number will be required in future as population ages as will the pool of healthy volunteer prospects.

- The expectation of a tax deducted could attract additional volunteers.

- Volunteers can provide time (worth money) but not necessarily cash. Both types

of donation are required.

- Volunteerism can be rewarded with a tax deduction.

- The loss of government revenue would be more than offset by the additional quality or maintenance of services provided by non-profit organizations therefore not requiring government subsidies.

In Ontario, high school students must provide a certain number of hours to a registered charity in order to graduate.

This precedent clearly indicates the importance of volunteerism and this act should be given the equal status as a monetary donation.

I am pleased to submit the aforementioned on behalf of all the tireless volunteers in Canada and would be happy to speak with

"the powers that be" to put this concept into the proper context and assist in any way to expedite the process.

Aurora's level crossings need to go, reader says

To the editor,

This past Saturday and Sunday gave Aurorans a good taste of the future of commuter rail in our town as GO trains frequently travelled back and forth on the Barrie line.

The rail traffic was due to the training of the new "customer-focused" Bombardier crews who will be taking over from the Canadian National crews.

While the emphasis on better customer service is laudable, I must point out that the Town of Aurora does not have the proper infrastructure to accommodate the amount of rail traffic that is coming very

soon.

According to GO's April 17 press release, "Residents of the communities in GO's service area, who may not be used to seeing GO Trains running during the weekend, should expect to see them starting this Saturday.

"Eventually, they will also see out-of-service GO Trains on the tracks on weekdays during mid-day and in the evening, outside regular schedules".

Added to this, GO Transit will soon add passing track to the Barrie line to better accommodate the increase in north-south rail traffic.

Aurora is literally cut in half by the Barrie line with three major level crossings at St. John's Sideroad, Wellington Street and Engelhard Drive.

That's a problem.

In particular, traffic on Wellington Street - Aurora's main east-west thoroughfare - often gets backed up to beyond Yonge Street on one side and beyond Industrial Parkway on the other when trains are passing through.

It is my view that the town should be working with the region and the province to eliminate these level crossings as soon as possible.

Aurora is growing.

There is going to be more east-west vehicle traffic.

There is also going to be more north-south rail traffic.

For residents living in 21st century, Aurora level crossings should become a quaint thing of the past.

Read the letters and ask yourself this: Who is really working to bring Ontario's electricity system into the 21st century in a way that truly addresses the climate and air quality impact of electricity

generation?

Who is really supporting the development of a conservation culture in Ontario? And who is just interested in maintaining the status quo?

I did, however, fully expect a schedule that would be manageable; meeting lengths that were reasonable (only occasionally excessive).

I also expected an atmosphere of respect for others and their opinions, a working atmosphere similar to most

business environments where discussion can and does take place without anger, threats and insults.

I expected a common goal to handle the business of the day with a lesser regard for personal opinions and personal agendas. I expected a group of nine that could and would work as a team, without obvious splits.

I expected to set policy and give direction that

staff would be left to implement and manage.

I expected the taxpayers' finances to be spent wisely and prudently and I expected the professional advice of senior staff to be independent and given the appropriate amount of weight and consideration.

To various degrees, these are not the realities of the current Town of Aurora Council, and whether it is a case of my expectations not

being reasonable, or whether there truly is a unique atmosphere this term, either way, I personally felt it was a situation that I could no longer tolerate.

Once again, I offer my humble apologies to the taxpayers of the Town of Aurora and my sincere thanks to those who have supported me and continue to do so.

Georgina had no rep at meetings

Response to - "Electrical plant will spread pollution through the air", a Letter to the Editor in the Georgina Advocate, April 24, and story "Georgina says no to gas-fired option," April 17.

The Ontario Power "Authority" (OPA) conducted the 2005 Northern York Region Working Group meetings and municipalities

from across the region had both citizen and municipal representatives at the table.

Why Georgina was not represented is a bit of a mystery but I am sure they would have been welcome given that six other municipalities were actively participating in this exhaustive consultation process.

York-North MPP Julia Munro was right to try and engage Georgina in this process and why they chose to stay silent

is a question only your elected officials can answer.

This issue was in the news extensively for over 18 months in 2004 and 2005 and these issues have always impacted the entire Region, but I presume that most people have little concern unless they are perceived to be directly and imminently impacted.

The need for a diverse supply of power that also addressed future growth needs has

already been clearly established by the IESO, OEB, OPA and local power distribution companies over the past few years and a solution will be imposed on us if we can not decide for ourselves how to best meet this need.

Conservation and Demand Management (CDM) are noble goals that should be pursued aggressively, as was stated by the OPA's 2005 recommendations as well as in their IPSP

master plan for Ontario, however CDM has absolutely no bearing on the need for supply diversity and redundancy.

The Clean Air Alliance's proposal for a 30MW CHP plant does not address the need for supply diversity and furthermore, upon closer scrutiny, their stance on emissions is not consistent with their past support of much larger facilities, that run longer and are located closer to much larger popula-

tions.

My greatest fear is that concerned residents and councils may rush to judgment without hearing all sides of the issue which is precisely why I created a website called Aurora Power Update.com (www.aurorapowerupdate.com).

It is my view that good output requires good input and I've done my best to inform the public over the past four years.

I totally support and

have advocated strongly for public input into this planning and assessment process but I have always assumed that input needs to be based on the best possible information.

I strongly support the OPA's proposal provided the power plant is properly located, designed and operated to address common and reasonable concerns.

Proposed facility not viable, reader says

To the editor,

RE: Proposed Power Generation Facility in Northern York Region.

Referring to The Auroran, week of April 15, Ontario Power Authority (OPA) proposed a plan to install a 350 MW simple cycle gas turbine electricity generating plant in Northern York Region, and its costs will be recovered through charges on customers' electricity bill.

Referring to further information retrieved from OPA's website, the gas fired electricity generating option has been a presence of community rather than a new transmission line that would provide the same relief.

At the end of the process, OPA will select only one facility to proceed with construction and operation.

I have assessed the subject facility based on the aforementioned information and common engineering practice.

My conclusion is that the proposed facility is not a viable solution to meet the best interests of all Ontario's electricity consumers.

The following summarizes my assessment why a simple cycle gas-fired electricity power generation is not a viable option.

1. Why is a simple cycle gas turbine electric generating facility not a viable solution?

There are two types of gas turbine electricity generating facilities in terms of thermodynamics.

One is a simple cycle unit and the other is a combined cycle unit.

The thermal efficiency of a simple cycle unit is at most 35 per cent, whilst that of a combined cycle unit is higher than

55 per cent.

A combined cycle electricity generating facility is a combination of simple cycle gas turbine unit(s) and a conventional condensing steam turbine unit utilizing heat recovery steam generators to recover the heat from the exhaust of gas turbine before discharging to the atmosphere.

Therefore, thermal efficiency of a combined cycle unit is much higher than that of a simple cycle unit.

The difference in thermal efficiency between the two types of gas turbine electricity generating facilities is in the area of 20 per cent.

Therefore, a simple cycle gas turbine electricity generating facility is not a viable solution, and therefore, it would not meet the best interests of Ontario electricity consumers.

2. Why was a simple

cycle gas turbine electric generating facility knowingly proposed?

In general, the electricity generating facility fueled by gas is for the purpose to meet peak electricity demands.

Common engineering practice for provision of a peaking electricity generating facility is to select the efficiency of facility as high as possible in order to minimize the payback period of investment by reducing production cost.

Therefore, a combined cycle unit is a far better selection in lieu of a simple cycle unit.

However, a combined cycle unit requires a lot of cooling water for its condensing turbine, and there is almost no suitable site available in Northern York Region for installation of a 350 MW capacity combined cycle electric generating plant.

OPA must have proposed a simple cycle

gas turbine electric generating facility knowingly in order to meet the preference of the community.

Therefore, in my opinion, OPA must seek public consensus in the decision making process in order to clarify the questionable engineering decision.

In fact, if a gas fuelled power generating facility were to be considered, the optimum solution for provision of a peaking gas turbine power generating facility to meet OPA's mandate should be of a high efficiency combined cycle unit installed at one of Ontario Power Generation's generating stations along the shore of Lake Ontario.

With a difference in thermal efficiency of 20 per cent, the losses in the transmission line to Northern York Region can be well offset by far by a higher efficient

combined cycle peaking unit.

3. Requirements of city water.

The Town of Aurora was listed as one of the sites running to install the subject facility.

OPA stated that "very little or no water will be used".

However, without question, city water or other sources of cooling water is required to cool down the auxiliary equipment.

The Town of Aurora disallowed residents to use city water for lawn care of their properties during the summer months in the last couple of years.

Readers must be aware of the fact the facility will be a system resource, and its costs will be charged on customers' electricity bills to all Ontario electricity consumers.

Furthermore, as mentioned, at the end of the

process OPA will select only one facility between the gas-fired simple cycle option and the transmission line option to proceed with construction and operation.

Therefore, OPA's advertisement in the media appears to be the last call for all Ontario electricity consumers in order to obtain public consensus prior to proceeding with construction and operation.

As one of the electricity consumers in Northern York Region, I strongly feel that it is unfair and also unethical to all Ontario electricity consumers for they will have to pay unnecessary higher electricity costs resulting from this gas-fired simple cycle power generating option.

In my terminology, this option is an engineering joke!

Budget passed...finally

After almost seven months and innumerable special committee meetings discussing Aurora's 2008 operating and capital budget, it was assumed the final passage would be a routine affair. Not so.

Bottom line: your taxes will increase 5.4 per cent.

More than three hours were spent Tuesday night debating various parts of the budget with recorded votes, points of order, nit-picking, and personal remarks before the final vote, which was adopted 8-1 vote with Councillor Evelyn Buck opposed.

In a power point presentation, Treasurer John Gutteridge noted the proposed budget included operating expenditures of \$39 million with net operating expenditures of \$21.9 million to be levied as taxes.

The 2008 gross capital budget has capital expenditures of \$14.1 million consisting of 48 projects with net expenditures of \$2.7 million to be added to the levy.

With assessment growth of 2.7 per cent there will be a tax levy increase of 4.4 per cent for operations plus one per cent to assist mak-

ing up the shortfall in capital funding for a total increase of 5.4 per cent or \$59.21 for town purposes on the average assessed house.

With regional and educational taxes included the increase for the average home is \$117.47.

From the Aurora tax dollar, 24 cents is for protection to persons and property, 19 cents for Leisure Services, 12 cents for transportation, 11 cents for Library, 11 cents for administration, 11 cents for capital, six cents environmental, three cents for planning and development and three cents for council.

The increase in the operating budget includes \$1.5 million for salaries and wages, \$180,000 for winter maintenance and \$25,000 for a Senior Grant Program.

A look to the future indicates a tax increase of 7.7 per cent next year, 5.3 per cent in 2010 and 5.3 per cent in 2011.

The Treasurer reported that the municipality was in a good financial position.

In response to a question from Councillor Buck about funds for hearings of the Ontario Municipal

Board, especially the Westhill appeal, staffers replied \$125,000 had been included in the legal budget and there was \$413,000 in the Legal Services Reserve.

Councillor Evelina MacEachern moved the budget as presented, with Councilor Buck stating that she couldn't support the budget as she had no confidence in it, claiming it was a political or an "Evelina MacEachern" budget which immediately brought an objection from Councillor MacEachern.

Mayor Phyllis Morris ruled councillors refrain from making personal remarks.

Buck maintained the community was not being well served by the budget as members of council had disregarded staff's advice.

Other councillors expressed confidence in the budget and it was adopted with the deletion of the one per cent capital levy.

Aurora council had previously set two budget deadlines and neither had been met: one in December and the other early in the new year.

Due to the 2006 municipal election, council didn't get started on the 2007 budget until they had assumed office and with five new councillors there was a learning curve and the budget was approved in April with a four per cent increase.

In order to get an earlier start for this budget, in July 2007 council set an aggressive schedule.

It didn't work out.

The budget debate is finally over.



The Facts About Needed Electricity Generation



What You Might Want To Know About The Proposed Power Generation Facility in Northern York Region

Important decisions are being made about how to meet the continually increasing electricity demands of Northern York Region, including the communities of Aurora, Newmarket, East Gwillimbury, Bradford, West Gwillimbury, King Township, Whitchurch Stouffville and Georgina. The Ontario Power Authority (OPA) would like you to know the facts about these decisions.

As part of Ontario's plan for ensuring the adequacy of the provincial electricity system, OPA has developed a plan to address the urgent electricity needs of Northern York Region. The plan balances a range of considerations including the needs that must be met and their costs.

The communities of Northern York Region are in critical need of electricity at times of peak demand

The Region is a priority area that requires special attention to assure ongoing reliability and security of electricity supply. The communities' most urgent need is the supply of power during high-cost, high-demand periods – especially hot windless summer days. The plant is expected to operate less than 10% of the time or eight to nine hundred hours a year.

The OPA is in the process of choosing a developer to design, own, and operate a rapid response power generation facility in the area. Our Request for Qualifications closed on March 28th. Currently, we are reviewing the numerous submissions to determine a short-list of qualified proponents. We expect to publish this short-list by the end of April.

This important step is part of a long-term solution to meeting the Region's electricity needs that began with community consultations in 2005. This solution includes a combination of conservation, completed upgrades to the existing Armitage Transformer Station, a new transformer station at Holland Junction currently under construction, and the proposed rapid response electricity generation source. This gas-fired facility is scheduled to be operational by the end of 2011.

It's A Matter Of Reliability

Ontario's power system has to respond immediately

Moment-to-moment, the electrical supply needs for Ontario, including Northern York Region, are managed by the Independent Electricity System Operator (IESO). Their rules of operation require that Ontario's electricity supply is robust enough to meet the province's needs – even if there is a major system outage. Ontario's power system has to have capacity at the ready – not just enough to meet demand needs today. The technical word is redundancy – but what that really means is reliability – a province-wide electricity system that can be relied upon to be there when it's needed and be ready to ramp up whenever it's required.

It's About Peace of Mind

There is only one transmission line serving Northern York Region. It's a 230 kV line that runs northeast through Vaughan, King, East Gwillimbury, and Georgina. Currently, there is no significant power generation from within the region itself so that almost all of the electricity needs for every home, business, and indeed every user, such as hospitals and schools – has to be served by this single transmission line. An outage on this line may cause disruption until it is repaired, meaning perhaps hours or even days until power is restored.

Through extensive public input in 2005, the community determined that adding another transmission line was not the preferred option. Therefore, it is critical that the community has on-demand, reliable power generation from within the region itself. It's a matter of public well being that street lighting, stop lights and signals, hospitals and schools, and homes are reliably powered. Only when alternative supply is readily available, can the community be secure in the knowledge that their electricity is always available.



Another drive-thru coming to Aurora?

A public planning meeting was held last week to consider an application from Imperial Oil for an amendment to the zoning bylaw to permit a drive-thru/take-out restaurant as an additional permitted use to the existing zoning category.

In 2006, the property located at the northwest corner of Leslie Street and Wellington Street East, was developed for an Esso gas station consisting of a convenience store, gas pump islands and a car wash.

Staff members advised to facilitate the proposed drive-thru restaurant within the convenience store and associated stacking lane, the site plan had been modified from the original approved plan and the revised site plan is now under review.

Staffers also noted that the proposal is being considered relative to the drive-thru study currently being conducted, with a report scheduled to be presented to council in the near future.

The Imperial Oil proposal conforms to the proposed drive-thru crite-

ria developed to date with a 30-metre distance separation and screening and sound attenuation.

It was also pointed out that the Accessibility Advisory Committee had recommended the site plan agreement requires Imperial to provide full gas service for a minimum of six hours per day.

All town departments and regional officials have reviewed the proposal and had no comments.

Staff members suggested if council determines there is merit in the proposal, the application be approved in principle subject to the resolution of outstanding issues and staff be directed to prepare the implementing bylaw.

Representing Imperial Oil, Don Dussault said he agreed with the report and the proposal was submitted due to the many customers using the station and the convenience store.

In a video presentation he noted the various improvements to be made to the site with the addition of trees, shrubs and a stone wall with "Aurora"

on it as a gateway feature. Referring to the request for full service he noted that the Accessibility Advisory Committee recommendation was for future stations and this was an existing station and the application was only for the drive-thru.

He also outlined the company's existing policy for all stations whereby seniors and disabled could receive full service by phoning the station 24 hours in advance and arranging a time when a second staff member was available to provide the service.

There were no members of the public in attendance in support or opposition to the application and after a few questions for clarification, on a motion by Councillor Al Wilson, the application was approved in principle subject to the resolution of outstanding issues.

Some prices stay the same

The Ontario Energy Board (OEB) recently announced that the Regulated Price Plan (RPP) two tiered prices, currently in place for residential and low volume customers of local electricity distribution companies, such as PowerStream, Inc., will remain unchanged for the next six months beginning May 1, 2008.

PowerStream Inc. is the third largest local electricity distribution company in Ontario, providing service to more than 237,000 residential and business customers including Aurora.

As in previous years, the consumption threshold limit will change on May 1 from the winter threshold of 1,000 kilowatt hours (kWh) per month to the summer threshold of 600 kWh per month.

Non-residential consumers eligible for the RPP prices will continue to use 750 kWh each month as their consumption threshold.

The RPP price remains at 5.0 cents per kWh up to 600 kWh and 5.9 cents per kWh above that.

The prices announced by the OEB, and changes in the threshold amount at the lower prices, are reflected on the "Electricity" line of a utility bill.

The threshold change results in fewer kWhs of electricity used in the summer to be charged at the lower price for residential customers and is meant to encourage conservation during the period of highest consumption.

Therefore, without a change in consumption, a typical residential customer may see an increase in the "Electricity" line of their utility bill.

The RPP pricing applies to customers who buy their electricity through PowerStream, Inc.

RUMOURS AND RAMBLINGS**Bicentennial Showcase started here**

It's not every small community in Ontario that is selected to premiere a major government program but it happened in Aurora in July, 1984, when the Bicentennial Showcase opened in Aurora for the start of a province-wide tour.

The Showcase was a 90-minute family variety program based on Ontario's 200 years of cultural development and featuring some of Ontario's top entertainers, including Dinah Christie.

In addition to the entertainers, the \$1 million production included more than 1,700 colour slides projected on a huge background screen coordinated with video scenes and live video playback of the performers and audience.

Guests for the premiere included Walter Pitman, executive director of the Ontario Arts Council; Arthur Gelber, Chairman of the Ontario Bicentennial; CN Tower Director David Garrick; Major General Richard Rohmer and Bicentennial committee members, Steve Otto and Norm Best.

The show opened with the entire company singing the lively Bicentennial theme song "Celebrate Ontario" and the program focused on the decades with such themes as Our Northland, The Seventies, Folk Spirit, The Sixties, The Classic Arts, The Fifties, The Big Bands Entertain and The Forties.

The second half of the show took the capacity audience at the Community Centre back to the beginnings and offered a challenge for the future in Watch Us Grow.

The finale was a tribute to the late classic pianist Glenn Gould.

The year 1984 was selected as the date for the Bicentennial as it was in 1784 when the United Empire Loyalists, the first large wave of immigration, settled in the province.

It was a night to remember in Aurora.

LAND DIVISION COMMITTEE RETURNS TO AURORA

It was in April, 1984, when the region released its hold on land severances through

the Regional Land Division Committee and returned the role to the local municipalities.

It had been a sore point between the local municipalities and the region since the region was established in 1971, as it gave the region some direct planning control over what happened in Aurora and the other municipalities.

It was claimed by regional planning officials that the local municipalities were granting too many severances and development was taking place without going through the proper planning process and causing an unknown load on the regional infrastructure.

As the local municipalities acquired planning staff and established planning departments the push for the return of the severance function gained pressure and eventually it was returned.

On its return to Aurora, council agreed to assign the responsibility of land severances to the Committee of Adjustment consisting of five citizens, independent of council.

A LOOK AT AURORA IN 2004

In the first year of the term for council approval was given for the construction of the Aurora Recreation Centre, the Seniors' Centre and a Fire Hall.

A start was made on a new cinema for Aurora and the State Farm Office Complex.

The first leash-free dog park was opened and 70 new Leisure Services programs were introduced as well as the town's web site.

There were 1,452 fire calls of which 24 per cent were false alarms, 39 per cent medical calls, 13 per cent public hazards and only seven per cent were actual fire calls.

The Building Department issued 1,147 permits and Leisure Services processed 11,710 activity registrations.

A total of 14 zoning bylaw amendments were filed as well as 17 site plans and amendments plus three plans of condominiums were registered.

There were 63 council, public planning, general committee and special council meet-

ings held.

It cost \$61.32 in operating costs for every tonne of garbage and \$111.84 in operating costs for every tonne of recycling and the town recycled 28.39 per cent of residential waste.

WHEN THE GRAYSTONE HIT THE HEADLINES

The Graystone Restaurant made the headlines in the local press in January, 1970, as during a council debate about taking out a business membership in the Aurora Highlands Golf Club, then Reeve Evelyn Buck said she would be embarrassed to take official town visitors to some of the town's eating establishments.

Her statements upset Max Wiedemann of the Graystone Restaurant and Ken Stiff who operated La Colony, now the Filly and the Firkin, across the street from the Graystone.

They invited members of council to visit their establishments and offer constructive criticism as to how they could improve in order to represent the public interest.

Some council members including Pete Miller, Norm Stewart and Illyd Harris along with Deputy Clerk Cam Duncan accepted the invitation and dined at the Graystone.

They assured the Wiedemanns the Graystone had excellent facilities and food.

A small private dining room later became a favourite spot for members of council every Tuesday night along with the staff of the former Aurora Banner, under the leadership of Publisher Bob Buchanan, after they had put the paper together for the printing press.

In June, 1973, then Mayor Evelyn Buck was invited to officially open the Graystone's new Bavarian Garden, an outdoor patio in front of the restaurant, which succumbed when the restaurant expanded its indoor facilities.

Councillors received some unexpected news at last week's meeting when staff members advised the Aurora Bingo Hall on Industrial Parkway South would close at the end of next month.

In addition to the loss of revenue for many local charities and organizations, the town will experience a shortfall of \$135,000 in 2008 or one half a per cent on the tax levy and one per cent or \$230,000 in future years.

The news could also spell the end of Hot Spot, a club set up for youngsters which has been in existence for 17 years and depended on the bingo hall for much of its revenue.

Councillor Wendy Gaertner told The Auroran the club may have to close out their operations at the Aurora Lions Hall, unless another source of revenue can be found.

The sale of town lands causes council debate

Following a previous closed meeting, council reported Tuesday that five offers to purchase parts or all of the town-owned Leslie Street lands had been rejected and no reasons or details were provided.

Councillor Wendy Gaertner explained that some bids were below the price the town had originally paid for the property and the other bids were below the appraised value of the property.

It was still for sale, she said.

Councillor Evelyn Buck interjected that the whole process was tainted and when asked to explain by Mayor Phyllis Morris, she refused to do so.

The councillor said the mayor didn't have the authority to ask.

When the mayor said it would be necessary to obtain a legal opinion, Councillor Alison Collins-Mrakas said none of the issue would be necessary if Councillor Buck would only explain what she meant by the comment.

Councillor Buck said that previously four members of council demanded copies of the confidential package available to bidders and it had been agreed to provide

them on condition they signed a confidentially agreement, which three signed and one didn't.

One of those members later declared a conflict of interest due to a business relationship.

Councillor Evelina MacEachern, who had declared a conflict of interest, jumped to the defence and stated that she had signed the agreement and this was confirmed by staff and resented the insinuation saying that Buck had "loose lips".

After order was restored the report from the closed meeting was received as information.

In June, 2007, following a closed session of council approval was given to declare the Leslie Street lands surplus to municipal needs and staff was directed to initiate the process to sell the lands.

They were also asked to issue a Request for Proposal for a real estate broker to handle the sale and in September council engaged the firm of Colliers McAuley Nichols and agreed to their proposed marketing strategy and timetable.

The 89 acres on Leslie Street, south of Wellington,

were purchased in 2000 for \$4.2 million for recreational and industrial uses, although the property and old farmhouse was assessed at only \$381,000.

The purchase of the lands was seen to be a major impetus to the attraction of future business to the municipality and the development of the employment lands at Highway 404 and Wellington Street East.

A consulting firm was engaged in January, 2002, to prepare development concepts for the parcel of land and following several working sessions council received a development concept incorporating a mixture of employment, recreational uses and a fire hall.

Then in June, 2003, following a closed meeting, council approved the purchase of 32 acres of land on Wellington Street East for \$4.8 million for a recreational complex, parkland and fire hall.

With the purchase of the Wellington Street lands there was no longer a need to provide recreational facilities resulting in a change of the concept plans and increasing the potential of the Leslie Street lands for employment uses.

A draft plan of subdivision was approved by council in April, 2006, and approved by the Ontario Municipal Board in December with conditions.

Staff recommended that council sell the lands while the market for employment lands was still strong and provided three options: sell the land by tender, sell the lands by utilizing a Real Estate Brokerage or retain the lands for future uses.

Councillors had some difficulty in arriving at a decision and finally in June, 2007, issued a Request for Proposals for a Real Estate Brokerage firm.

In September, 2007, council received a presentation from a representative of the real estate firm who provided an outline of the marketing strategy and critical path which was adopted by council.

Over the months some councillors were critical of the firm's marketing strategy although staff pointed out that 31 prospective buyers had responded to the campaign and a report would be coming to council in the near future.

The sale of the land continues and if the first report is any indication, it could be a rocky road.



Blooming issue back in the light

If Carol Cooper, a member of the Environmental Advisory Committee, gets her way, Aurora may finally enter the annual Communities in Bloom event.

At a committee meeting last November, she said she would investigate involvement in the event.

Other communities in York Region have competed in the event over the years, either at the Provincial or National level, and won awards, but not Aurora.

At the January meeting of the Environmental Advisory Committee it was agreed to ask the town to support the Community in Bloom event and that Ms Cooper be the liaison between the committee and the event organizers for the 2008 Communities in Bloom competition.

The committee recommendation was endorsed by the Aurora's general committee recently without comment or discussion.

At the meeting, while discussing council's priority list, the question of the status of the Communities in Bloom event was questioned as to whether the town was in or not.

Staff members replied that clarification was needed regarding the budget and the process was to be discussed at the next committee meeting.

It was suggested that as the process was just getting started that plans be made for 2009.

Councillor Evelyn Buck claimed that some neighbouring municipalities were spending thousands of dollars to enter the competition and she was not prepared to

spend that kind of money.

The list of priority items was referred to a future meeting with staff.

It was back in September, 2005, Aurora resident Rebecca Beaton attended a meeting of the Leisure Services Advisory Committee to ask that Aurora pursue the Communities in Bloom initiative for 2006.

She suggested the program be community driven, incorporating residential, industrial and commercial participants.

For a start she suggested the town only enter the provincial competition at an estimated cost of \$1,000.

The Canadian-based non-profit program looks at floor displays, landscapes, urban forests, community involvement and tidiness.

She added that sponsors had already been

approached and would absorb the cost of the 1st, 2nd and 3rd place plaques, and asked that a program committee be established as soon as possible.

The committee agreed to recommend to council that the initiative proceed and the town not be required to commit the \$1,000.

With the Howard Johnson hotel willing to accommodate judges, the cost would be reduced to about \$750.

At that time, Councillors John West and Evelyn Buck opposed the request pending more information as to possible hidden costs.

Councillor Buck said that other municipalities had spent thousands of dollars on the program and the \$750 would be wasted unless Aurora was prepared to do the

same.

Most members of council supported the recommendation to participate and to approve the expenditure of \$750 to register.

In October, 2005, Ms Beaton provided an overview of the Communities in Bloom initiative to the Environmental Advisory Committee which had been approved by council.

She asked the committee to support the initiative which committee members agreed to do. The committee also agreed that the seminar topic for April, 2006, be tied to the Communities in Bloom program.

Council gave its approval to enter the 2006 Provincial Communities in Bloom Competition in September, 2005, but there was no follow up.

No more funds for library: council

Last November, Aurora's general committee directed staff to get a report on the 6.6 per cent increase for the Aurora Public Library's 2008 operating budget and for the report to include a breakdown of the major contributing factors for the increase.

Also the report would include a listing of any elements within the proposed Space Development Project which could be attributed to development charges and that a review of the fundraising campaign account be provided.

In February the general committee recommended that the Library Board 2008 budget be increased by four per cent over the 2007 budget.

Library Board Chairman Geoffrey Dawe and CEO Louise Proctor Maio appeared before council Tuesday to make a presentation with regard to the 2008 Library Budget.

It was pointed out that to meet the four per cent target it would be necessary to hold the annual contribution to the General Operating reserve at the 2007 level, gapping the cost for the new staff posi-

tion to reflect mid-year implementation costs and holding the Collection Development budget at the 2007 level

It was also noted that flat lining the Collection Development would impact the library's ability to provide new materials.

As council is proposing to adopt a municipal budget with a 5.4 per cent increase which includes an increase of 4.4 per cent for operating and one per cent for capital, a request was made for the library to receive the same increase in order to better meet the collection needs of residents.

Councillor Grace Marsh, supported by Councillor Evelyn Buck, recommended that the library request be approved.

Councillor Buck pointed out that as 2008 had been proclaimed as the Year of Arts and Culture in Aurora it was not a year to cut back on the library and it

would amount to a small amount of money in the overall budget, estimated at \$28,000.


Other councillors argued that the proposed library budget was costing tax payers 11 cents on the dollar and with the loss of revenue to the town from the Aurora bingo hall, there was no way council could approve an increase.

The debate raged back and forth with both sides arguing their points.

Councillor Al Wilson expressed concern that council had no control over the library budget once it had been approved by council.

It was also noted that the library ended 2007 with a surplus of \$37,000.

When the vote to provide the extra funding was called, it was defeated 5-4 with Councillors Marsh, Buck, Alison Collins-Mrakas and Bob McRoberts in support of the motion.



