## Town gets green light for rec site

It took all of five minutes.

Aurora Council, in a rare show of togetherness Thursday night, agreed unanimously to proceed with the purchase of a 32-acre parcel of land in Aurora's east end.

The land, located on Wellington Street, just west of Leslie, has been the Burnett homestead for decades.

Stu Burnett is a former Reeve of the Township of Whitchurch, where the property was located prior to the birth of regional government in 1970.

Sources say the Burnett family is excited about the proposal and suggested they didn't want their land to become another subdivision.

Included in the plans is a large recreational facility that is expected to include two ice pads, a swimming pool and possibly a

youth centre.

Twenty-seven acres of the parcel are developable, with the remainder classified as wetlands.

Cost of the land purchase is estimated at \$4.8 million. No figures have been released on how much the complex construction might cost.

While portions of the property permit public facilities, part of the land is currently designated for medium density residential, and in order to permit the construction of the recreation site, a public meeting will be held in September.

The proposal, announced publicly for the first time last week, came about as a result of over-capacity demand on the town's recreational facilities.

"As the update of the Culture and Recreation Master Plan unfolded, it became apparent to council that

## Library Square history a comedy of errors

If it wasn't so serious, the trials and tribulations of planning the Library Square redevelopment could be described as a comedy of errors.

The recent debate of the future of Church Street School, the old library, senior's centre and Victoria Hall was reminiscent of previous

studies, reports and debates but none quite as acrimonious as the most recent disaster.

In July, 1985, council approved terms of reference for a study of the public lands around the Victoria Street library, including the Browning property purchased earlier in 1985.

The Browning property on Yonge

Street was acquired to provide a new main entrance to the addition to the library and access to the public buildings on Victoria Street.

The study was designed to examine future uses for the four-acre property along Church Street between Yonge Street and Victoria Street.

The area included two acres of

town-owned property, along with commercial and residential properties on the balance of the land.

In February, 1989, council reviewed the various town-owned facilities...again.

At that time, consideration was given to converting the former fire hall, later the parks building, into a seniors' centre, as had been dis-

cussed for years.

At that time the seniors' were housed in the Church Street School, which was overcrowded and inaccessible to many.

Based on projections at the time, it was believed the renovated fire hall would provide adequate accommodation for seniors for a

# We're in good shape, mayor says of region

Full bang for the buck is what Aurora's mayor Tim Jones is after for the town's taxpayers.

Referring to the newly released York Region 2002 annual report, Jones said the region was in good shape.

# St. Andrew's hosts hotbed of pipers and drummers

Aurora's St. Andrew's College played host to 120 pipers and drummers from across North America, as the independent boys' school presented the sixth annual Ontario School of Piping and Drumming last week.

The camp featured instructors from Scotland, Nova Scotia and Ontario, and included Willie McCallum of Glasgow, generally regarded as the leading piper in the world today. Also on the teaching roster were Ian MacDonald, Pipe Major of the Toronto Police Pipe Band, and Bruce Gandy, who last year won the prestigious Highland Society of London's Gold Medal at the world's premier piping competition in Inverness, Scotland.

Jim McGillivray, Director of the piping camp and also Director of the full-time Piping and Drumming Department at St. Andrew's says, "The school is particularly attractive for U.S. pipers who often don't have the same access to quality instruction that local pipers and drummers do in the piping hotbed of Ontario."

Eighty percent of the clientele are from south of the border, he said, and people come from as far away as Alabama, California, Hawaii, Louisiana, New Mexico and New York.

"The pipers love the chance to immerse themselves in their instrument for two solid weeks, with some of the best players and teachers in the world helping them out and per-

forming for them," McGillivray said. "They also love the campus and the whole Aurora area. It's a great vacation for them, even though they are working hard, too."

The camp was also attended by local pipers and drummers from Aurora, Newmarket, Markham and Toronto.

One hundred of the 120 attendees boarded at the school for the sessions.

The summer school is part of the St. Andrew's College piping and drumming program that also teaches the art form as an academic credit course to students from Grades 9 to 12.

Boys also learn the pipes and drums as part of the school's Cadet Program, which fields a massive and resplendent pipe band

each year for the Cadet Corps' Annual Inspection in May.

Instructors at the school performed in recital in the St. Andrew's College Great Hall last week.

A CD of previous years' recitals will be available, as well as the St. Andrew's College-produced Pipes and Drums CD, Quit Ye Like Men.

## Budget vs. promises

*Preparing the annual budget,  
Must be very carefully done.  
Money can't be spent in isolation,  
Or the battle will never be won  
-Poor Richard's Scrapbook*

The annual budget should be considered as a planning document for the fiscal year based on anticipated expenditures and revenue, including provincial grants, user fees, other revenues and the property tax, and based on the ability of the taxpayer to pay.

Unfortunately councils today commit expenditures in isolation from the budget process and then have to juggle the budget, sometimes referred to as creative financing, to balance the books.

Aurora's nine-year record of a tax freeze, came home to roost in 2000 with a tax increase of 5.6 per cent. This was followed by increases of 8.4 per cent in 2001, 8.8 per cent in 2002 and 5.9 per cent in 2003 for a total of 28.7 per cent increase over the four years.

Treasurer Allan Evelyn in presenting the 2003 budget noted that the deferred costs of the past could no longer be deferred with a potential 9.2 per cent tax increase in 2004 and 8.2 per cent in 2005.

This represented an increase of \$273 on the average home during the 2003-2005 period, without incurring any new projects.

While not approved yet, council received a report in June recommending the management information system be updated at an estimated cost of \$1.8 million over a five-year period.

About the same time council promised the seniors a new custom-built seniors' centre on town-owned land south of the town hall at an estimated cost of \$2.1 million with no idea of where the money will come from.

At a previous meeting council recognized the need for two additional ice pads and a swimming pool to be built, plus other municipal facilities, including a new fire hall with no cost estimates at the time.

There is a long outstanding commitment to provide a youth centre with no thoughts as to where and how much it will cost. It isn't just the construction costs that must be considered, but the ongoing operating costs that must be included for all new facilities.

A recent staff report points out that with the growth of the municipality, winter maintenance costs for roadways and sidewalks are increasing resulting in a longer periods for snow clearing, or increasing the number of snow-clearing routes at an additional cost.

These are just a few of the future costs that council is considering with little or no thought as to where the money is coming from and if the taxpayers can afford to pay the bill.

Following a recent private session, council agreed to purchase property for a multi-purpose recreation centre to include two ice pads, swimming pool and other facilities for \$4.8 million to be ready in two years. These were the reasons the Leslie Street property was purchased for more than \$4 million.

In addition there are demands at the regional level for money for policing, rapid transit, and improved roadways, plus the mandate of the provincial government for water quality improvement and other measures that all add to the property tax bill.

Much of this was discussed or action taken in isolation from the budget process leaving staff in the difficult position of trying to find funds to maintain a balanced budget.

Aurora Council adopted a strategic plan, which sets out the municipality's goals and describes the necessary action to achieve these goals. The plan was updated in 1998 with the document "Aurora's Way Ahead", approved in 1999.

The plan includes as one of its goals to provide citizens with a well-managed and fiscally responsible municipality. As a taxpayer, you can decide if this goal has been achieved and if you can afford to pay for all council's promises. Think about it before the November 10th municipal election.

## Following up

Sometimes the nickel just refuses to drop. Couple of weeks ago, we ran a headline that indicated a former mayoralty candidate would not seek "re-election". Of course he wouldn't, he had never been elected! Thanks to all the keen eyes and logical thinkers who caught this "fox pox".



Some weeks ago, we ran photos and a story of the Gateway Plaza located on Wellington Street and Haida Drive. The above photo shows the plaza under construction at an intersection that had no sidewalks, no traffic lights and no trees. It did have a station wagon, though. The original building opened with room for about eight stores. The photo was taken in April, 1963.

# Aurora is "bedroom town", reader says

I suppose we should be offended by the revelations made by Mia and Julia Toth (Letter, Auroran, July 1).

But, we are not because we discovered shortly after moving here 32 years ago that Aurora was (and is) a true Toronto bedroom community offering nothing in the way of shopping and little in the way of entertainment.

Therefore, we go to either Newmarket or Toronto for virtually all our needs.

We have watched businesses come and go in Aurora and have always been amazed at the apparent lack of market analysis on the part of entrepreneurs.

Lack of adequate off-Yonge street parking, horrific traffic congestion at the corner of Yonge-Wellington

and the inability of Aurora Mom/Pop businesses to compete with the Big Box stores north of Davis Drive pretty much consign Aurora to a 19th century town sans hitching posts.

The annual Yonge Street extravaganza staged by the Aurora merchants and supported by Town Council is cute.

But I doubt if it translates into significant business growth.

The problem, as I see it, lies in a decision made many years ago to maintain Aurora as a residential town with a historic rural flavour.

This was romantic but not practical.

A part of the plan was achieved (a residential town). But the proximity of Yonge Street doomed the retention of any rural historic quality.

The growth of the Toronto megalopolis has doomed the survival of many historically unique communities in the GTA.

The foresight (or lack of such) by merchants and town councils have determined in perpetuity the nature of these towns.

Newmarket chose the 20th/21st centuries and Aurora got caught in a time warp between the 19th/20th centuries.

Nevertheless, we enjoy 'hanging our hats' in Aurora precisely because of the residential emphasis.

If all this seems contradictory, let me hasten to add that few people hold consistent views on anything.

Everything works. I have money because I forgot to pay my bills and the machine is willing to give me some. Things are looking up.

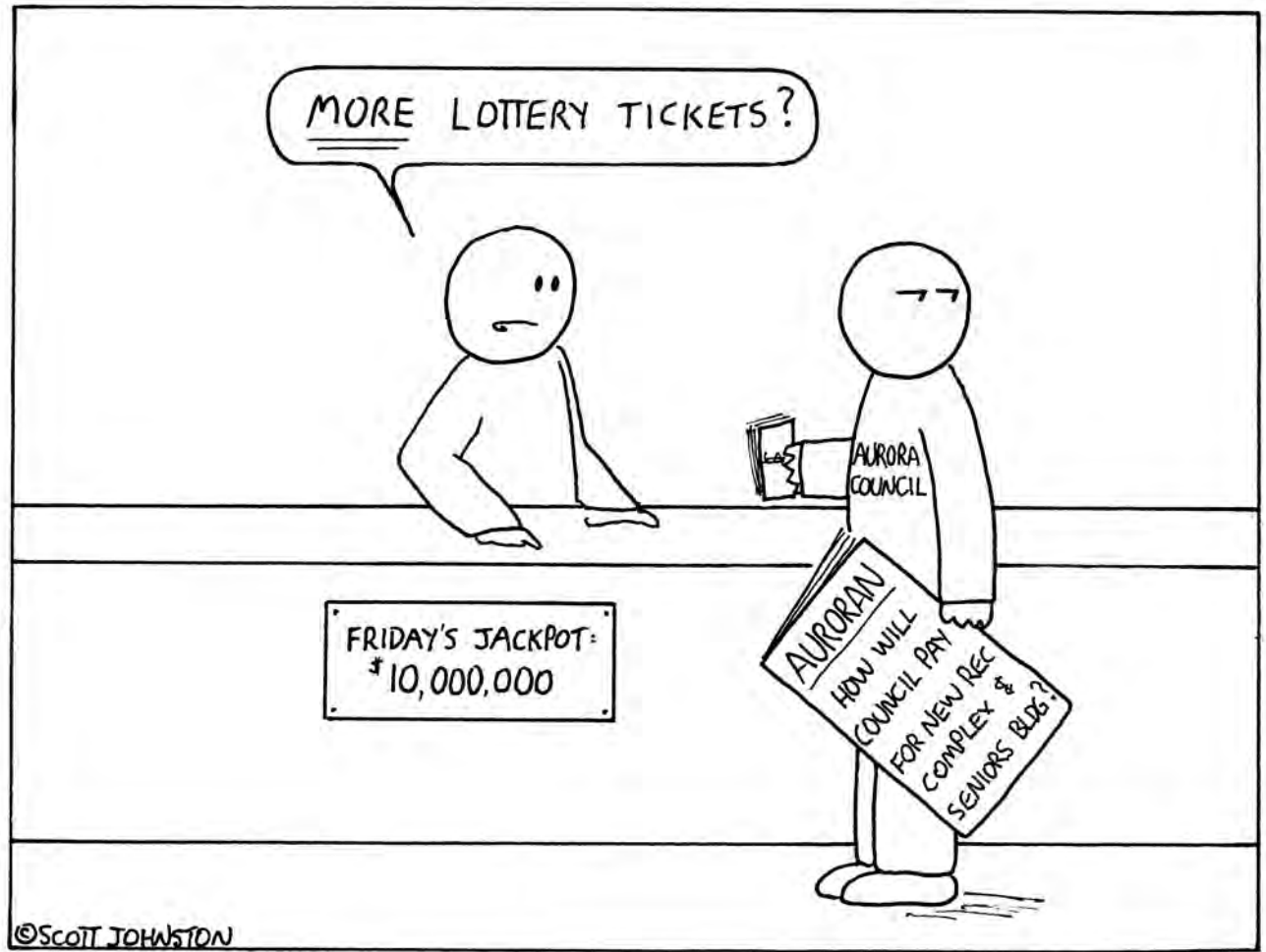
I turn to leave and hear: "Hi, Cathy!" Oh, no! Life can't be this cruel! It's my bank manager.

# A look back at Aurora's downtown in the fifties

Long before the current convenience store opened on Wellington Street East, just to the east of the Toronto Dominion Bank, there was a Home Hardware store, and the first IGA store in Canada operated by Larry Rubin.

And before that, the building was a general store operated by the Fingold family.

There was the mother and the father, sons Phil and Harvey and daughter Shirley. It was a combination grocery and dry goods store with a huge opening in the wall between the two stores.

There was also Rolling's fruit store across from the Fingold store, Joe Mitchell's hardware store, and Frank Teasdale's grocery store were located farther east on Wellington Street.

The Queen's Hotel was located at the corner where the TD bank is now located and across the road was the Bank of Montreal, Aurora's oldest operating business.

On Yonge Street there was Cousins Dairy where the now-closed Trio restaurant is located while the Aurora Dairy was at the northeast corner of

Centre and Yonge Streets. Both had popular dairy bars.

Next door to the north of the former Trio was a building that housed the Bell Telephone exchange and later a dental office, before it was demolished and converted into an office building.

South, Elwood Davis had a garage and the motor vehicle licence office. The office is now located on Mary Street and is still operated by Elwood's daughter, Jan.

Ernie Holman operated the Esso station at the corner of Yonge Street and Cousins Drive. There was also a Shell and Texaco station at Ransom and Yonge and a Gulf station at Church and Yonge Streets.

Ron Simmons operated a butcher store at Tyler and Yonge Street. The Knowles and Morris families operated butcher shops on Wellington Street.

Nixon Fisher had a popular 5 and 10 cent store on Yonge Street, next to Mary's Fruit Market, one of the oldest businesses on Yonge Street.

Another old time Yonge Street business is Thompson's Fine

Furniture, who until a few years ago also operated the funeral home on Victoria Street.

Scanlon Bakery and Spence Bakery were also located on Yonge Street as was Jack Chapman's blacksmith shop and Case's home ice delivery service.

There were several small grocery stores including Dominion, Cameron Loblaw's, and Lacey's.

There were the Morning, Hess and Willis drug stores in the Yonge Street downtown core, two jewelry stores, Marshall Rank

and Allison McConnell, and two Chinese restaurants, Dan's and Ray's, which later became Moon Garden.

Retail stores included Ardill's Ladies Wear where the Larter Building is now located, Norm Cook's Men's Wear, Chet Osborne's Shoes and Clothing, Simmon's Shoes and both an Eaton and Simpson order office.

There were many other businesses and people back in the 1950s who helped to make downtown Aurora a busy and interesting place to be.

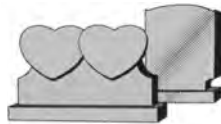

# Unanswered questions highlight Aurora events

On May 15, 2001, during a routine check, Aurora works department staff discovered an oil spill in the watercourse emanating from the Industrial Parkway outfall leading to the East Holland River.

Both the York Region Spill Control and the Ministry of the Environment were notified.

As well as several defined contained areas of oil contamination in the watercourse, both banks of the watercourse were contaminated with oil.

It was originally believed that the oil had been dumped at the outfall. After further investigation, however, it was determined that the source was farther upstream

in the storm sewer, due to staining along the bottom of the pipe.

Storm manholes along the Industrial Parkway from Scanlon Court to Industry Street were inspected in an unsuccessful attempt to find the source of the spill.

A week later there was continuing evidence of contamination but to a lesser degree. Cost of cleanup to that time was approximately \$20,000, not including staff time and materials.

By July town officials had still not received any information from the Environment Ministry regarding the testing ministry officials had carried out at the time the spill was found.

The town engaged an environmental consultant to carry out testing but they were unable to obtain accurate readings as a possible source of the contamination was on private property and they were unable to contact the absentee landowner for permission to enter the property.

By mid-August, the costs of the on-going cleanup were estimated at \$130,000 and unless the source of the contamination could be found, the cost would have to be borne by taxpayers.

MOE officials reported that the results of the testing were inconclusive with 80 per cent organics, 10 per cent paint chips and 10 per cent rust.

The results of testing carried out by the town's consultant showed varying types and concentrations of chemicals. The investigation centred on numbers 12 and 16 Industrial Parkway South, based on previous information.

In a report to a December meeting of the general committee, the consultant said three general contaminants had been found in the spill: solvents, gasoline and diesel/heavy oils, leading to the conclusion that three sources were involved.

The evidence was insufficient to identify a source, or sources of the contaminants, which left councillors frustrated

homes.

One of their concerns was what they claimed was a flow of water under the surface of the ground at or near the east side of the development damaging their property from flooding. They claimed they had never experienced flooding problems prior to the development.

At a subsequent council meeting staff reported that a check had been made of town documents for any reference of water problems or concerns that would indicate the presence of an underground stream in the

area but nothing could be found.

The developer commissioned a consultant to undertake a geotechnical investigation of the area and reported there was no evidence of an underground source of water.

Yet, Councillors Ron Wallace, David Griffith and Betty Pedersen who had lived in the area recalled that in the seventies there was a stream in the area.

Traces of the missing stream could not be located in spite of the flooding of the Seaton Drive homes and the mystery remains.

# The 404 - a long, long time coming

Back in 1961 the Aurora Board of Trade expressed concern about the increasing traffic on Yonge Street through the town.

An invitation was extended to a traffic engineer from the Ontario Department of Highways to attend one of their meetings to discuss the situation.

At a later meeting a depart-

ment traffic official told the board members that their concerns about Yonge Street traffic would evaporate when Highway 404 snaked its way northward to Aurora and Newmarket.

Asked when the highway would provide some relief for Aurora, he replied, "sometime after 1965".

Thirteen years later, April,

1978, a Ministry of Transportation official told Aurora Council that Highway 404 should reach Aurora by 1982 or 1983.

Council granted the ministry permission to assume parts of the St. John's Sideroad and the Vandorf Sideroad for construction purposes in conjunction with the planned Highway 404.

At that time the highway extended north to Steeles Avenue in Metropolitan Toronto and was expected to reach Highway 7 by the end of 1978.

The contract for construction up to the Gormley Sideroad, expected to take two years, had not even been tendered at that time.

Eventually that section of the highway was completed and Aurora motorists waited for the highway to reach the municipality.

In August, 1984, it was announced that tenders had been called for the stretch of highway between Bloomington and Wellington Street East and by early October, 1985, the work was substantially complete, except for pavement markings and cleanup.

York North MPP Bill Hodgson announced that construction between Sheppard Avenue to Bloomington Road had cost \$55 million and was expected to cost another \$12 million to extend it to Davis

Drive.

He added that good roadways bring new business and opportunity and when completed should encourage residential and industrial growth for Aurora and Newmarket.

Previously when every section of Highway 404 was completed between major east/west arterial roads, there was an official opening with all the trimmings.

When the section between Bloomington Road and Wellington Street was opened in October, 1985, there were no ribbons, no speeches, no nothing. Workers took the barriers down and traffic started to flow.

While Aurora motorists could travel southward on the new highway, they were unable to head north as the highway terminated at Wellington Street.

In October, 1997, former Ontario Transportation Minister Al Palladini told the Aurora Chamber of Commerce that the northward extension of Highway 404 was still a government priority.

By that time the highway had reached Davis Drive in Newmarket.

Now Aurora motorists can use Highway 404 to commute to downtown Toronto and can go as far north as Green Lane.

The provincial government statement by a provin-

It did open.

As for the Yonge Street traffic. One merely has to venture through Yonge and Wellington to realize there has been no relief in the volume of traffic.

# Library square confusion a comedy

seven to eight year period or until about 1997.

At the time of the 1989 report there were no long-term plans for the future of the Church Street School or other town-owned buildings in what had become known as the Library Square or the Cultural District.

In September, 1992, council established the Church Street School Ad Hoc Committee to consider uses of the building in conjunction with other town-owned buildings in the area.

Almost 10 years later, during 2001 budget deliberations, staff suggested a consultant be engaged to review redevelopment for the town buildings in the library-square. Council rejected the suggestion and sought other options.

At the April 24, 2001, council meeting, staff recommended the appointment of a joint council/citizen committee for the study.

In spite of objections that the recommendation had never been discussed by the Leisure Services Advisory Committee, council approved terms of reference for the committee.

The committee's mandate was to make recommendations for the allocation of space in the town-

owned buildings in the square.

A total of 21 applications for space had been received and were being considered by the committee.

In December, 2001, Steve Grainger appeared before a general committee to present a survey prepared by some of the applicants in the project.

The survey was critical of what was seen as an incomplete, partial and restricted application process, flaws in the problem-solving/decision-making process and failure to consider alternative methods, lack of an open process and accuracy of the minutes of the committee meetings.

Committee members directed questions to Grainger with some members becoming more belligerent in their questioning and arguing.

As the library square committee had met all summer and had not reached a consensus or a point they could make any recommendations, Councillor Ron Wallace, a committee member, recommended the group be disbanded.

The motion carried unanimously.

Then when the committee report came to the December 11, 2001, council meeting, it was back to square one for the redevel-

opment project as council endorsed the motion to disband the committee.

The debate started all over again with the hiring of the consultant.

Councillor John West insisted the terms of reference for the consultant include a reference to the seniors taking over the main and upper floor of the old library.

Other members argued there was little sense in engaging an architect to carry out an independent review if council tied his hands. As a result, it was finally agreed not to hire a consultant but to refer the whole issue back to staff to report on comments made by council members.

In January last year council approved terms for an evaluation of the old library and the existing seniors' centre. The report was presented to council in August.

It indicated a substantial amount of work was required to the old library regardless of future uses, but especially if it was to become the seniors' centre.

Significant issues included new roofing, floor replacements, wall repairs, new heating and air conditioning, replacement plumbing and parking lot improvements at an estimated cost of \$421,250. That was later revised to \$538,000.

Last month, staff presented three options to the

seniors' building steering committee. They included the move to the old library, demolition of the old library and seniors' centre to construct an apartment complex with a seniors' centre on the bottom two floors, and seeking a site outside the downtown core.

The seniors' steering committee supported the demolition option, which had never been discussed in council at an open session.

It also came as a surprise to members of the seniors' centre, resulting in the issue being deferred for two weeks until the seniors could hold a general meeting to review the options.

During the discussion at council Councillor West casually mentioned a possible site might be the town-owned property south of the town hall, but it was never discussed or approved by members of council.

However it was presented as an option to the seniors and supported by a 58.5 per cent vote. This resulted in another raucous council meeting.

Finally last week after two hours of heated discussion and several personal attacks, council agreed unanimously for

staff to investigate the feasibility of the proposed site and to report back with

methods of financing and a timetable.

The comedy continues.

the need for recreational facilities had to be addressed immediately," Chief Administrative Officer Larry Allison said. "Recent demand analysis has resulted in a determination by council that these facilities should be constructed earlier than originally planned."

If everything works, the new facilities could be operational in two years.

"We are very excited about this tremendous investment," said Mayor Tim Jones. "Council and staff conducted an intensive review of a number of properties, based on a series of characteristics including budget considerations and this property satisfied all established parameters."

Staff will now begin working closely with community groups in an effort to develop a strategy to support their on-going recreational needs.

"It is essential that we include our community groups in the planning and development stages," said Director of Leisure Services Al Downey. "We value every comment and concern that these groups provide to us."

Officials were quick to react to the fact the town already owns 89 acres of land on Leslie Street, south

of Wellington, and noted the proposal could not move ahead swiftly on those lands because the acreage is not serviced.

"The Burnett lands already have services to them," said Mayor Jones. "The Town intends to fully leverage the opportunities associated with the 89-acre investment on Leslie to

benefit the current acquisition."

In other words, once servicing arrives at that land, it will be sold to the private sector.

A new fire hall was proposed for the Leslie property, and while that may still happen, it has been pencilled in on the Burnett lands.

# RUMOURS & RUMBLINGS

## FIRE HALL IDEA NOTHING NEW

Council is currently considering demolishing the old library and fire hall on Victoria Street and building a five-storey seniors' apartment complex with a seniors' centre on the bottom two floors.

Back in April, 1979, there were other plans for the old fire hall.

Dr. Steve Andrews, an Oak Court resident, visualized the empty fire hall as a beehive of activity by installing three squash courts, an indoor swimming pool and platform tennis on the roof.

He made the proposal at a public meeting held to discuss the future of various Victoria Street buildings.

Former Mayor Evelyn Buck made the only other suggestion for the fire hall. She wanted it used as a satellite fire station.

After all these years, the future of the buildings on Victoria Street is still being discussed!

## NOCTURNAL COFFEE SHOP

Today 24-hour coffee shops are quite common but back in November, 1968, a midnight coffee spot in downtown Aurora announced it would no longer be open for late hour snacks after more than 35 years of the nocturnal service.

Ray's Café on Yonge Street, currently Moon Garden, shortened its closing hour from 1 a.m. to 6 p.m. Monday to Thursday and 7 p.m. Friday to Sunday.

Early morning coffee lovers were also disap-

pointed as the café opened at 7 a.m. instead of 6 a.m. and on Sundays it was 9 a.m.

## A RECRUITING FIRM FOR AURORA

It was in April, 1985, when a new Aurora company was offering Aurora and area firms a chance to obtain some help to get over those periods when extra staff was needed on a temporary basis.

The Aurora Business and Personnel Services was started by Pamela Fry of Aurora and Jane Fraser of Sharon, both competent business-women.

The talent they had available included secretary-typists, word processor operators, switchboard staff and bookkeepers.

Not only did the firm assist businesses to fill positions on a temporary basis, it also attracted people looking for work, including several highly skilled women who were anxious to get back into the workforce on a temporary basis.

As well as placing people at local companies, they also accepted work to do in their basement office in the Fry home such as correspondence, reports, resumes and bookkeeping.

## BATTLE OVER BEFORE IT STARTED

It was in October, 1985, when a group of George Street residents came to an Aurora public planning meeting ready for a fight, but before they had a chance to use their weapons, the battle was over.

The meeting was called to consider an application for an 11-unit apartment building on George Street, just north of the George Street Public School, submitted by Dr. Steve Armata, who planned to sever his land to begin the project.

Then Mayor Dick Illingworth told the meeting that the town had received a letter that day from Dr. Armata withdrawing the application.

There was stunned silence for a moment, then there was resounding applause.

"Can't we make our speeches, anyway?" asked one resident.

## PROPOSAL NEVER HAPPENED

It was in May, 1975, when Aurora Council postponed a decision on an application for a proposed gas station and commercial mall on Wellington Street between Ross Street and the Industrial Parkway.

The postponement came about as the result of a request from the applicant as some of the principals of the project were out of the country.

Although few details of the proposal were available, several people at the meeting expressed concern about a gas station and strip plaza on what would soon be a major entrance to the town from Highway 404.

They stressed the need to maintain a good appearance along Wellington Street and not allow it to become another commercial strip like Yonge Street.

They also pointed out that Aurora didn't need another gas station.

The public planning meeting was held and the application developed into a full-scale debate on development east of the CN tracks.

Many of the same arguments about the type of development for Wellington Street East were made and the development never proceeded.


